Coverage Description:

The Campus Boiler & Machinery Program insures all property of every description both real and personal (including improvements, betterment, and remodeling), of the Member, or property of others in the care, custody or control of the Member, for which the Member is liable, or under obligation to insure – subject to all terms, conditions and exclusions.

Perils Covered:

Boiler explosion and machinery breakdown

Total Insured Values:

\$2,570,391,803 as of June 20, 2025

Coverage Limit: \$100,000,000

Boiler Explosion and Machinery Breakdown, (for those Named Insureds that purchase this optional dedicated coverage) as respects Combined Property Damage and Business Interruption/Extra Expense (Including Bond Revenue Interest Payments where Values Reported and excluding Business Interruption for power generating facilities unless otherwise specified). Limit includes loss adjustment agreement and electronic computer or electronic data processing equipment with the following sub-limits:

Sub-Limits:

1. Jurisdictional and Inspections Included
2. Per Occurrence for Service/Utility/Off Premises Power Interruption \$10,000,000
3. Per Occurrence for Consequential Damage/Perishable Goods/Spoilage Included
4. Per Occurrence for Electronic Data Processing Media and Data Restoration \$10,000,000
5. Per Occurrence, Per Named Insured and in the Annual Aggregate per Declaration for Earthquake Resultant Damage for Named Insureds who purchase Dedicated Earthquake Coverage \$2,000,000
6. Per Occurrence for Hazardous Substances / Pollutants / Decontamination \$10,000,000
7. Per Occurrence for Machine or Apparatus used for Research, Diagnosis, Medication, Surgical, Therapeutic, Dental or Pathological Purposes Included
8. Automatic Acquisition for Boiler & Machinery values at newly acquired locations. Values greater than \$25,000,000 or Power Generating Facilities must be reported within 120 days and must have prior underwriting approval prior to binding \$25,000,000

Valuations:

Repair or Replacement except Actual Loss sustained for all Time Element coverages

AORMA Risk Pool: \$100,000 per occurrence

Member Deductibles:

1. Except losses to Real Property \$5,000
2. Losses to Real Property with Total Insurable Values of \$10,000,000 or Less \$5,000
3. Losses to Real Property with Total Insurable Values between \$10,000,001 and \$25,000,000 \$10,000
4. Losses to Real Property with Total Insurable Values between \$25,000,001 and \$50,000,000 \$25,000
5. Losses to Real Property with Total Insurable Values of \$50,000,001 or more..... \$50,000
6. Deep Water Wells \$10 per foot / \$2,500 Minimum
7. Utility Interruption 24 Hours
8. Business Interruption/Extra Expense Except as noted below 24 Hours
9. Business Interruption - Revenue Bond 30 Days
10. Business Interruption - All objects over 750 hp or 10,000 KW/KVA/Amps or 10,000 square feet heating surface 5 x 100% of Daily Value
11. Business interruption - All Objects at Wastewater Treatment Facilities and All Utilities..... 5 x 100% of Daily Value

Exclusions: *(Including but not limited to)*

1. Testing
2. Explosion, except for steam or centrifugal explosion
3. Explosion of gas or unconsumed fuel from furnace of the boiler

Objects Excluded: *(Including but not limited to)*

1. Insulating or refractory material
2. Buried Vessels or Piping
